### 2 Pages - Please read completely

### **ALL CONTESTANTS MUST:**

- be a High School Student, in Grades 9 through 12, in good standing with their school.
- (For students enrolled in a NJ high school equivalency program, please contact the program coordinator for eligibility.) • be a resident of New Jersey.
- Contestants can enter as an individual or a group; [Groups cannot exceed six (6) students]

#### SONGS MUST:

- be <u>completely original music and lyrics</u> with no copyright infringement violations.
- be no more than 3 (THREE) minutes in length.
- contain a strong prevention message.
- Copyright-protected songs: Please carefully read Paragraph 5 of the Copyright License, Talent and Release Agreement before entering contest.

MUSIC/LYRICS: Two versions of your song must be submitted:

- One version must contain music and all vocals.
- One version must contain **music only** (soundtrack/instrumental) \*If you wish to perform at the Concert to a recorded soundtrack instead of live instruments, please include any background vocals on this track).
- Must be submitted electronically, in an MP3 format. (Any other format will not upload) Follow uploading instructions on www.ShoutDownDrugs.com/register. (Anyone who cannot meet this requirement should contact the program coordinator.)
- Typed lyrics, with a song title, must be uploaded with music.
- TWO FORMS: must be completed by all participants and mailed. (see below). GROUPS must mail forms together.
- **PHOTO:** Must upload with your music. Be as creative as you like, but you must follow copyright rules. (Groups: one group photo only). PDFNJ reserves the right to reject any images it deems unacceptable.

**CONCERT:** Each participant **MUST BE AVAILABLE** to perform at the Prevention Concert on Friday, April 27, 2018, at Daytop-NJ, Mendham, New Jersey. Rehearsal at 3:00 P.M./Concert 7:00 P.M., *if chosen as a Finalist.* Participants who are not available on this date will be disgualified from the contest.

• Groups: No substitutions are allowed for any group member who cannot perform on April 27, 2018. Remaining group members may still perform if they wish but must contact program administrator for permission.

• Chaperones must accompany Finalists to Rehearsal (3:00 PM) and Concert (7:00 PM) on April 27, 2018.

• Entry Form (NJSDD18-1) -Groups: Group members must complete own separate Entry Forms and mail together.\*\*

• Copyright License, Assignment and Talent and Release Agreement (*NJSDD18 – 2*) Groups: One form per group <u>but each group member or parent/guardian must sign.</u> \*\*

\*\*<u>If under the age of 18,</u> both forms must be signed by parent or legal guardian. If <u>over the age of 18</u> proof of age must be included (copy of *birth certificate* or *driver's license*).

### **DEADLINE:** THURSDAY, FEBRUARY 1:

- Song, Soundtrack/Instrumental, Photo and Lyrics must be uploaded on www.ShoutDownDrugs.com/register. \*\* DO NOT WAIT FOR THE LAST DAY TO UPLOAD to allow time for possible technical difficulties!!
- Entry Forms <u>Postmarked</u> no later than Thursday, FEBRUARY 1, 2018 and mailed or delivered to: Partnership for a Drug-Free New Jersey, NJSDD, 155 Millburn Avenue, Millburn, New Jersey 07041.

# JUDGING

- Independent panels of judges will select County Finalists to perform in the Statewide Concert and select the 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> Place Winners at the Concert.
- Judges will select one Finalist from each of New Jersey's 21 participating counties to perform at the Prevention Concert; however, PDFNJ reserves the right to select additional "Wildcard" Finalists.
- Participants will represent the county where they reside, not where they attend school. (For group entries, the group leader's residing county is the group's official county of entry.)

### • Online Voting Dates:

All Entries posted:  $2/16/18 \rightarrow \text{Contestant}$  with most online votes becomes **Automatic Finalist!** Finalists posted:  $3/5/17 - 4/26/18 \rightarrow \text{Finalists'}$  total online votes will be combined with Judges' scores night of concert to help select 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> Place Winners.

## Finalists Will Be Announced Mon., March 5, 2018, at 3:00 PM on www.ShoutDownDrugs.com and www.DrugFreeNJ.org:

- Each Finalist is required to perform at the Statewide Concert on Friday., April 27, 2018 at Daytop-NJ, Mendham, New Jersey. (Rehearsal 3:00 P.M., Concert 7:00 P.M.) ALL FINALISTS MUST ATTEND THE 3:00 PM REHEARSAL.
- First, Second and Third Place Winners will be chosen at this event.
- All decisions are final.

### JUDGING CRITERIA ~ Emphasis will be placed on your Prevention Message ~

#### 1. Prevention Message/Lyrics:

- Is the message clear?
- Is the message effective in peer to peer substance abuse prevention?
- 2. Originality:
  - Does the song motivate/inspire peers to be drug-free?
  - Does the song inform peers about the dangers of substance abuse?
- 3. Voice / Performance

### PRIZES

### First Place Winner (individual or group)

- will be awarded a \$5,000 "Music Contract"
- will be required to perform their winning song at a <u>minimum of four (4)</u> separate statewide events\*, which shall be determined at a future date. Prize will be distributed in accordance with the terms of the music contract and contingent on performance at scheduled PDFNJ events.

### Second Place Winner (individual or group)

- will be awarded a \$3,000 "Music Contract"
- will be required to perform their winning song at a <u>minimum of three (3)</u> separate statewide events\*, which shall be determined at a future date. Prize will be distributed in accordance with the terms of the music contract and contingent on performance at scheduled PDFNJ events.

#### Third Place Winner (individual or group)

- will be awarded a \$2,000 "Music Contract"
- will be required to perform their winning song at a <u>minimum of two (2)</u> statewide events\*, which shall be determined at a future date. Prize will be distributed in accordance with the terms of the music contract and contingent on performance at scheduled PDFNJ event

\*Winners are responsible for their own transportation to each of these events and minors must be accompanied by a chaperone 21 or older. <u>PLEASE NOTE</u>, if a group is chosen as the 1<sup>st</sup>, 2<sup>nd</sup> or 3<sup>rd</sup> Place Winner, the prize money will be divided equally among group members.

## **EXCLUSIONS**

Contest is <u>not open to past New Jersey Shout Down Drugs® Winners</u> but other past contestants may enter. Contest is not open to employees and immediate family members of PDFNJ, nor any Sponsor of this contest. - End of Rules -
